... when we prevent people from obeying the law, we place them and ourselves needlessly at risk. Senate Bill 60 [a bill that would have allowed all drivers, regardless of immigration status, to obtain a license] corrects that inequity by allowing everyone who wants to operate a vehicle to do so legally by obtaining a license and purchasing required insurance.
