On September 5, 2017 the Acting Secretary of Homeland Security issued a memorandum rescinding the June 15, 2012, memorandum entitled "Exercising Prosecutorial Discretion with Respect to Individuals Who came to the United States As Children," which established a program known as the Deferred Action for Childhood Arrivals (DACA). Joint Task Force-West South Texas Corridor J2 Intelligence Section is currently working on a Bi-weekly report for South Texas Corridor Command Staff, and one of the topics being covered is the number of Deferred Action for Childhood Arrivals recipients.
