





The "Stop Dangerous Sanctuary Cities Act" Will Put Critical Community and Public Works Funding at Risk

Updated JULY 2016

This week the Senate will skip the committee process and go directly to the floor as Sen. Majority Leader Mitch McConnell brings up a vote on the "Stop Dangerous Sanctuary Cities Act" (S. 3100), sponsored by Senators Pat Toomey (R-PA) and Jim Inhofe (R-OK). This proposal will put millions of dollars of funding for federal infrastructure, economic development, public housing, schools, and hospitals in jeopardy for cities and counties with community trust policies. These law enforcement-backed policies increase public safety by nurturing trust between law enforcement officials and the communities they police. Nevertheless, they are being targeted by conservatives who want to turn police officers into deportation agents. Rather than letting local officials and law enforcement decide how best to protect their communities, this bill attempts to bully them to adopt harmful one-size fits-all policies by threatening to withhold critical funding streams.

The bill targets the Economic Development Administration Grants and the Community Development Block Grants, which allow cities and states across the nation to invest in building stronger and safer communities. The table below lists states that would be in danger of losing significant funding:

Methodology:

The calculations above are based upon adding up the individual funding that each jurisdiction (cities and counties) purported to have a community trust policy in a given state receives, as well as state-level funding for states that have community trust policies, for each of the programs listed above. In each of the states listed, one or more localities are reported to have a community trust policy based on research by the Immigrant Legal Resource Center.
