

# Documents Typically Used by Lawfully Present Immigrants

The table below lists the documents that various categories of lawfully present individuals may have. Some people who are lawfully present in the U.S. may have documents that are not listed here, while some will not have ready access to these documents. The specific immigration codes and categories could be helpful in identifying individuals who may be eligible for ACA coverage or certain public benefit programs.
